

In enrolling on your program for the training of My Dog (the "Training Program"), I hereby confirm and agree with you as follows:

1. I warrant and undertake with you that:
 - (a) I am the registered owner of My Dog;
 - (b) I have procured My Dog to have received all necessary inoculations and medications before the 1st session of the Training Program; and
 - (c) I shall notify you immediately of all information or developments relating to My Dog in particular to the health, behaviour and well being of My Dog.
2. I shall ensure that a responsible person who is competent to handle My Dog during each session of the Training Program and shall remain with My Dog at all times while it is in training and its immediate vicinity.
3. I understand and acknowledge that some dogs can accept a great deal of training in 6 sessions, others are just getting started. The average adult dog needs 6 months of intensive training to become proficient. Obedience training may take less time dependent upon what I, the owner, expect to get done and upon how diligent I am with the follow up at home. If I am not diligent, I do not expect a fully trained dog. I understand that the successes of training strongly depends on three factors: an owner's willingness to heed the advice of the trainer (the professional), proper reinforcement at home and maintaining an open line of communication with the trainer. Cooperation from all parties is key.
4. I understand and acknowledge that the attendance of the Training Program is not without risk to My Dog and / or myself and / or My Group and / or our personal properties as we shall sometimes be exposed to other dogs and persons and their personal properties in Training. I further understand and acknowledge that loss, damage, injury, death, disappearance or theft or consequential or indirect loss may occur to My Dog and / or myself and / or My Group and / or our personal properties as a result of such risk.
5. In connection with clause (4) above, I agree that K9SDS shall not be responsible for such loss, damage, injury, death, disappearance or theft or consequential or indirect loss and I further agree to hold K9SDS harmless from all or any such claims caused directly or indirectly by negligence or otherwise or any other cause whatever by other persons or dogs in Training to My Dog and / or myself and / or My Group and / or our personal properties. The trainers, are not responsible for injury, death, or loss of the dog. K9SDS is not liable for any dog that escapes from the training facility/site/location. Also, owners are responsible for any veterinary fees incurred if medical attention is required. Owner's further attest that said canine was in good health when training issued.
6. I agree to indemnify K9SDS against any loss of or damage to property or bodily injury or consequential or indirect loss sustained by it by reason of any act or neglect or any other

cause whatever of My Dog and / or myself and / or My Group while in Training. Notice of all claims by K9SDS in respect of any loss damage or injury or consequential or indirect loss shall be given in writing to me at the address given in this Agreement.

7. I agree that the fee I pay for the Training Program is non-refundable and that My Dog's failure to attend one or more sessions after I have signed up for the Training Program and having paid the required fee will be at my own expense. The validity of the program is 6 months from the date of this contract. Any unused lesson will be void. The trainer reserves the right to terminate this contract at any give time. The trainer is in no way responsible for the dog not retaining the training once the lessons are over, due to absence of maintenance training by the client.
8. I covenant with K9SDS that:
 - (a) I shall not or procure any members of My Group for a period of 18 months after ceasing to attend the Training Program and without the prior written consent of K9SDS in connection with the carrying on of any business similar or in competition with the business of training dogs and / or the sale of animal products on my own behalf or on behalf of any firm or company directly or indirectly:
 - (i) seek to procure orders from or do business with any person firm or company who has at any time during the period of 18 months immediately preceding such cesser attended the Training Program or any other training program carried out by K9SDS or done business with K9SDS;
 - (ii) endeavour to entice away from K9SDS any person who has at any time during the period of 18 months immediately preceding such cesser been employed or engaged by K9SDS;provided that nothing in this clause shall prohibit the seeking or procuring of orders or doing of business not relating or similar to the business or businesses described above.
 - (b) I shall not or procure any members of My Group in Singapore and for a period of 18 months after ceasing to attend the Training Program carried out by K9SDS and without the prior written consent of K9SDS either alone or jointly with or as manager agent consultant trainer instructor or employee of any person firm or company directly or indirectly carry on or be engaged in any activity or business which shall be in competition with the business of training dogs and the sale of animal products.
9. This contract is the sole agreement between K9SDS and the owner. Any agreements, promises, negotiations, or representation not expressed in this contract are no longer in force or effect. This agreement is governed by and shall be construed in accordance with the laws of the Republic of Singapore.
